



What is Dual Credit?



Simultaneously earn high school <u>and</u> college credit in <u>one</u> class!

Benefits of Being a Collin College Dual Credit Student

- Courses taught at Frisco ISD campuses and Collin College campus.
- Small class sizes.
- Personal attention from Collin College instructors.
- Begin a college transcript.
- Experience a college environment and the rigor of a college course.



How Much You Will Save!

UT Dallas: \$2,230 for a 3 credit hour course*

University of North Texas \$1,325 for a 3 credit hour course** * Based on Fall 2017 tuition rates

Collin College is <u>\$152</u> for same 3 hour course!!! (for in-county residents)

Dual Credit Courses are Transferable to Most Public Four-Year Colleges and Universities in Texas



Students are responsible for determining whether their transfer institution will accept their credits

Dual Credit Eligibility

- Students complete the <u>entire</u> Collin College admissions process plus a permission form for registration.
- Available with permission from your high school each semester for every course.
- Must meet college readiness standards as defined by Texas Success Initiative (TSI).
- Student must meet both high school and Collin College academic requirements to continue in the dual credit program.
 - If numeric grade of 60-69% is awarded in dual credit course, student will receive an on-level 70% on high school transcript. Letter grade of D will be listed on Collin College transcript.
 - Will not be eligible to continue with dual credit in that subject. Must enroll in high school section for next semester.

Is Dual Credit the Right Choice for Everyone?

Parents and students should consider goals, maturity, responsibility, and academic ability levels prior to enrolling in a dual credit program.

You might decide not to participate in dual credit if you:

- Are struggling with your other high school classes
- Feel overwhelmed with your current load of coursework and extracurricular activities
- Are not ready to take on college-level course work and the responsibilities of being a college student

Things to Consider...

The importance of attendance and time management

Student code of conduct

Drop/Withdraw deadlines

Maturity for subject matter and college classroom environment

Get to know your course syllabus and instructor

FERPA Family Educational Rights and Privacy Act

- Similar to HIPAA law.
- Federal law that ensures privacy of student educational records (*begins when student starts college <u>regardless of age</u>*).
- Collin College cannot share grades, course schedules, test scores, etc. with parents.
- A great opportunity for students to learn the college process and take on new responsibilities.
- Students can authorize confidential information to be released by completing a FERPA Authorization form.
- The FERPA Authorization is located on the student's CougarWeb account.
- This form is valid until the student revokes the authorization. There is no time limit for this form.

- Student will receive their Collin ID number (CWID), email address, CougarWeb username and password in <u>3-5 business days</u>.

Step 3: Official High School Transcript

- Follow your high school's specific steps to request one.
- Collin needs the most current high school transcript for every student.
 - Does not have to include final spring grades.
- May include test scores for TSI exemptions/waivers.

Step 4: Texas Success Initiative (TSI)

- The TSI is designed to measure college readiness in reading, writing, and mathematics.
- It is used for course placement purposes.
- Students must be at college level in reading and writing for the majority of courses.


Partial exemptions allowed provided that the required combined/composite score is met.

TSI Waivers

Scores must be on an official document from the high school (e.g. transcript or HS letterhead).

Waivers are only needed for the subject you want to take (e.g. you only need a waiver in reading and writing to take ENGL 1301, HIST 1301).

Step 5: Bacterial Meningitis Vaccination

- Dual Credit students taking classes <u>at any Collin campus</u> MUST provide proof of an having vaccination within 5 years if under the age of 22. *The* vaccination must be administered at least <u>10</u> days prior to start of entering term. This is an admissions requirement for Collin College and should be completed before registration.
- Dual Credit students taking classes <u>at their high school campus</u> may request for an exemption by completing a Request for Exception Form (gray form in the Collin College dual credit packet).

Step 6: Mandatory Online Training

Am I Okay to Register?

All dual credit paperwork must turned in and processed before holds are removed.

*Processing time is 3-5 days after paperwork is received by Collin.

Each admissions step is listed as holds, so all steps must be completed prior to registration.

A hold prevents registration. All holds must be cleared before you can register for courses.



Students are able to view holds via their CougarWeb account.



Step 7: Register for Courses Online via CougarWeb

All dual credit documents and transcripts must turned in and processed before holds are removed.

Registration Instructions

- Log into CougarWeb
- Go to Add or Drop classes
- Select Credit Fall 2018 term
- Enter the specific CRN for your designated course
- Then click *Submit*



Step 8: Pay Tuition

\$50 per credit hour for students residing in Collin County = \$152 for a 3 credit hour course


\$96 per credit hour for students residing in Denton County = <u>\$290</u> for a 3 credit hour course

Total cost per 3 credit hour course includes a \$2 per semester student records fee. *All fees subject to change upon approval of the Collin Board of Trustees.*


How to Pay Tuition Online
