**Frisco ISD declares no responsibility for and assumes no liability arising from fire, theft, vandalism, damage or loss of any vehicle or article left therein while located on school district property or while in tow.**

**The district has the right to search a vehicle driven to school by a student and parked on school property whenever there is reasonable belief that the vehicle contains articles or materials prohibited by the district. A student's refusal to comply and provide access to a vehicle that they drove to school and parked on school property whenever there is reasonable belief that the vehicle contains articles or materials prohibited by the district will result in the administering of consequences by an administrator that may include Out-of-School Suspension, In-School Suspension, loss of parking privilege, loss of extracurricular activity attendance or participation, and loss of attendance at other school sponsored activities.**

### Regulations and Fees

1. **\$50** – First and Second Semesters – Gives students approval to park in designated spaces during school hours  
**\$30** – Spring Semester Only (Begins Jan. 1<sup>st</sup>)
2. **\$10** – Replacement fee for lost, stolen, or misplaced permits.
3. The parking fee is non-refundable once the semester begins or if the parking permit is revoked. Students are responsible for safeguarding their permits.
4. Fines for not having sticker and/or not parking in designated student parking areas.
  - a. 1<sup>st</sup> Offense: **\$10** Fine
  - b. 2<sup>nd</sup> Offense: **\$10** Fine
  - c. 3<sup>rd</sup> Offense: **\$10** Fine
  - d. Additional Offenses: **\$15** Fine
5. Student Parking is not allowed in any staff designated areas, bus lanes, visitor parking, or any other non-student designated areas during the school day.
6. Temporary permits will only be issued to students who have purchased and displayed a Frisco ISD parking permit.
7. After receiving a fine, the student must go to the campus designee within (3) three days to pay the fine. Unpaid fines can result in a hold at registration, graduation or prom.
