EOC Testing Information:

Monday, May 5th (A day) will be the Algebra I EOC test. All students not taking the Algebra I EOC test or an AP Exam will follow their regular full day schedule.

Tuesday, May 6th (B day) will be the Biology and U.S. History EOC exams. Students not taking an EOC or AP Exam on **Tuesday** will arrive at 12:15 to attend 3rd and 4th period.

Please note, students taking Collin College Dual Credit courses at FHS during zero hour will meet for class in A201 at the regularly scheduled time for both May 5th and 6th. Students not testing need to leave campus after their college course.
