Dear Heritage Family:

Our semester is almost over! As we look ahead to the last week of school, please remember that we have a four-day holiday. We have no classes tomorrow and Monday is a holiday. Classes will resume on Tuesday, May 29th and it will be an 'A' day.

Mandatory graduation practice is Thursday, May 31st at 3:00 p.m. in the HHS gyms. Seniors will sign for their graduation packet at the end of practice.

As we look ahead to summer, please note the following:

All medications need to be picked up from the clinic. Please read the attached information regarding the district guidelines and procedures.

If you need to request a transcript over the summer, please go to www.friscoisd.org and type 'transcript' into the search icon at the top of the page. You can then follow the instructions for Parchment.

For registration information, please see our campus website regarding this information which will open July 31st.

For VOs (verification of enrollment), you may obtain one in the HHS Front Office Monday through Thursday throughout the month of June. Our campus will be shut down the week of July 2nd and July 9th, and during that time you will need to email isregistration@friscoisd.org and allow one business day for a reply. Our Front Office will reopen on Monday, July 16th.

We have reached the time of year where it's important to share information on a regular basis regarding our seniors and graduation. Very important information regarding seniors is included in a separate attachment to this letter. **Please be sure to read the attached information.**

Information was sent out earlier this week regarding medication pick-up in the school clinic. The information is attached as well to this letter.

As we approach the end of the school year, we need to provide you information regarding our hold list. Please visit [MyPaymentsPlus](#) to review your student's account and pay any fees due. Any students with unpaid amounts will be added to the Holds list at the end of the year. Students on the Holds list will not be eligible for early access to next year's course schedule.

Because textbooks are still needed in our classes for learning until the end of the school year, fees for textbooks are not assessed until the end. It's the last piece of the puzzle so that our students get the most out of their learning environment.

If your student has any textbooks issued to him/her and that textbook is not turned in, then your student will go on the hold list for the cost of that text book. This could mean that, for seniors, a senior or parent might not know until immediately prior to the mandatory graduation practice that we are holding graduation tickets until the hold list item has been taken care of. Please have a conversation with your senior regarding textbooks as well as any other fee or due that he/she might be responsible for paying prior to the end of the year.

It's not too early to think about our returning students as well! Please note that all returning students must complete all 3 items to be eligible for early access to 2018-2019 schedules. First, guardians will need to complete Power School registration (formerly InfoSnap). Power School link will be emailed to primary guardian by Frisco ISD district office. Second, guardians will need to submit a valid proof of residence in July or August. More information will be provided in July on our new electronic process for proof of residence submittals. Third, all fees associated with the student from prior years must be paid in full. These fees can be viewed and paid on [MyPaymentsPlus](#).
