**WHAT TO WEAR:**

**Clinic Sessions:** Appropriate dance attire (leotard or dance top, dance pants, and dance shoes) or workout wear. Dance shoes must be worn at all times for safety. *Please, no shorts, crop tops, spaghetti straps or running shoes.* Hair must be securely tied back at all times! No jewelry allowed!

**Tryouts:** A solid black leotard or black fitted top, long black dance leggings or capris, black socks and black jazz shoes. Hair will be in a low ponytail. No jewelry or fingernail polish of any color. Makeup should be worn to emphasize facial features. Hair accessories (bows, rhinestones clips, etc.), glitter eyeshadow, and body glitter are all prohibited. Audition number (given to hopefuls on the day of tryouts) must be pinned to chest. **PLEASE BRING 5-6 SAFETY PINS.** You may visit Sandy's Dancewear in Frisco for dance attire and shoes.

***The Seasons of Drill Team***

Season	Time Frame	Description
Summer	June-August	Reserved for required dance studio hours, Officer Camp, Line Camp, and August Training. Camp & practices are mandatory. Team & Individual photos in uniform.
Football	Aug-Nov	RR will perform at pep rallies, home/away football games (some Thursday or Friday), & FISD community parade. Members will tryout for each football routine & pep rally, excluding field hoop. Practices and performances are mandatory.
Basketball	Dec-Feb	RR will perform at 3 home basketball games (Tuesday or Friday night), contest (Saturday), host a dance contest at LHS. Members will tryout for each contest routine, excluding team military. Practices and performances are mandatory.
Revue	April	Spring Show is a production for 2 nights in the LHS auditorium. Practices & performances are mandatory.
Train	May	Officer tryouts, train and prepare team for required summer training, team building

# **FISD CRITERIA TO AUDITION**

**A candidate must meet the following FISD criteria to audition for drill team:**

*(Reference also FISD Dance/Drill Team Code of Conduct Guidelines, 2018-2019,  
Tryout Qualifications and Requirements)*

## **Requirements for Tryouts:**

1. Must not have been academically ineligible for two or more grading periods during the application school year.
2. Students must have acceptable disciplinary records for the current year. Students who have been assigned to either ISS, OSS or DAEP must have permission from the principal to participate in tryouts. The principal will take into consideration:
  - the circumstances of the disciplinary assignment
  - the student's past disciplinary history
  - the satisfactory completion of the assigned consequence prior to the tryout.
  - If a student has more than three days of ISS, OSS, or DAEP assignments they may be allowed to tryout under a probationary status if granted approval by the sponsor and campus administration.
  - Students in DAEP at the time of tryouts are not eligible to tryout.
  - Students assigned to the DAEP during the school year are not eligible to tryout.
3. After the first semester of the school year, students must have the following number of credits to tryout:
  - Incoming 9th Grade: on track to pass 8th grade and verified by both the outgoing and incoming principals
  - Current 9th Grade: 2.5 credits
  - Current 10th Grade: 7.5 credits
  - Current 11th Grade: 12.5 credits
4. Students must not have been absent (without making up those hours) for more than 10% of school days in a school year.
5. Students must be cleared through both the attendance and administrator's offices before being eligible to tryout. Documentation for this clearance will be based on campus preference, but must be on file before the tryout process begins.
6. The student code of conduct for extracurricular activity involvement will continue to be in effect.
7. The current year principal, in conference with the attending principal or designee and program director, will make the determination of eligibility to tryout (example: current 8th grade student's eligibility will be determined by their middle school principal, the local high school principal or administrative designee, and program director).
8. Tryouts may be video recorded if student is unavailable to tryout during the specified time because of a school sponsored or University Interscholastic League sponsored event, or if they are medically unable to tryout, with approval from the sponsor and campus administration. (doctor's documentation will be required).

INHERENT RISKS OF DANCE TEAM INHERENT RISKS OF DANCE TEAM DANCE TEAM:

Dance Team participation is reasonably safe as long as certain guidelines are followed, but there is the inherent risk of injury as in any athletic activity. Dance Team is an anaerobic/aerobic activity which includes jumping, stunting, motions, and tumbling. All physicals must be on file in the high school office before you may participate in practices and games. Keep your sponsor informed of all injuries and/or chronic conditions.

Although the probability of injury is minimized if you practice correctly, there is always the possibility of one occurring. Injuries that can occur in Dance Team include, but are not limited to, the following: Blisters, muscle strains, ligament sprains, joints and muscle soreness, abrasions, contusions, stress fractures, broken bones, spinal cord injuries involving paralysis, and even death. However, if you take certain precautions, the possibility of such injuries will be largely decreased.

BE SURE TO CONSISTENTLY ABIDE BY THE FOLLOWING GUIDELINES:

1. NEVER stunt or tumble unless a sponsor or sponsor's NEVER designee is present
2. Always practice in the presence of a qualified teacher
3. Always warm-up appropriately before dancing (practice and games) by jogging & stretching
4. Do not attempt a stunt that you do not know how to perform safely and that has not been checked off by the teacher
5. Always use attentive spotters when stunting
6. Always dance in an area free from obstruction
7. Always use mats or a grassy area when stunting during practice
8. Do not stunt on uneven ground, wet surfaces, and concrete
9. Do not stunt in cold or rainy weather
10. Never talk, laugh, mess around when performing a stunt
11. Report all injuries to the coach as soon as they occur
12. Follow all trainer and doctor recommendations
13. Lift weights to increase strength and guard against injuries
14. Always wear shoes and clothing appropriate for Dance Team
15. Never wear jewelry of any kind or chew gum when dancing (practice and games)
16. Always have your hair pulled back from your face and shoulders
17. Eat nutritious meals and get plenty of rest
18. Always ask for assistance or advice at any time
