SCHOOL NURSE

It brings me great joy to be your child's School Nurse. I've worked in Frisco ISD for more than 18 years. I hope this information is helpful in addressing the **Health Needs** of your child.

Medical History: These details can be communicated through the InfoSnap system provided by the district when you registered your student. Feel free to contact me via telephone or email if your student's medical needs have changed or if you have clinic related questions.

Medication Policy: Fisd does not provide medication. You must provide medication, prescribed or over-the counter, for your student. District approved over-the-counter medications are: Tylenol (Acetaminophen), Motrin/Advil (Ibuprofen), Tums, and Benadryl (Diphehydramine HCL). Over-the-counter medications must be in their original container and accompany a signed Fisd *Parents Request for Administration* form*.

Prescribed medications must have a label with the student's name, the medication name, the dosage, the instructions, & the primary care providers (PCP) name. For the safety of all student's at Scoggins, all medications must be kept in the clinic. Student's may carry their own inhaler or epi-pen once the Fisd *Self Administration of Prescription Asthma or Anaphylaxis Medication by Students* form* is completed & signed by their PCP.

Asthma, Food or Other Allergies, Seizures, or Diabetes: Each of these medical conditions have a specific form which can be found on the Fisd Health Services website*. Please submit a completed medical condition form or "Plan of Care" signed by your child's PCP and you.

Fever, Vomiting, Diarrhea or Head Lice: A fever is considered any temperature over 100.0 degrees Fahrenheit. A student must be fever free for 24 hours before returning to school. If your child vomits more than 2 times in 24 hours or has frequent episodes of diarrhea, they should stay home. If your child is treated for head lice, please contact me.

I look forward to meeting your child and you. My aim is to prevent disease or injury. I love teaching students how to live a healthy life of wellness.
